

## 2017 Hankook Tire Spring Rebate Program



All rebate claims and supporting documents must carry a postmark or equivalent no later than 11:59:59 PM, June 30<sup>th</sup>, 2017 or claims will be declared void.

If all rebate conditions are met, your Hankook Visa Prepaid Card<sup>1</sup> will be mailed to your mailing address approximately in eight (8) to ten (10) weeks upon receipt of a valid completed claim form.
